Sir,

with reference to a etition submitted in regard to your conviction by a General Court "artial on the 11th. June, 1915, when serving as a Lieutenant in the lat/7th. Battalion, The Gordon Highlanders (Territorial Force), I am commanded by the Army owneil to acquaint you that, after further consideration, His Pajesty the Ting has been pleased to grant you a pardon in respect of the sentence of cashiering, with restoration of your commission in the rank of Lieutenant in the 7th.Battelion. Gordon Highlanders, (Territorial Army), and transfer therefrom to the General List, Territorial Army Reserve, in such rank as may be decided, conditional upon the acceptance by you of a sentence of severe reprimmd, an on the further condition that such pardon and restoration of commission shall not carry with them pay or allowances for the period 22nd. June, 1915, to the date of the pardon, nor gratuity in respect of the period of your service which ended on the 22nd. June, 1915.

I am to say that upon the acceptance of these condition the pardon will become immediately operative and the necessary steps will be taken to give effect thereto by Gasette notice. I am to request that you will notify to this departue

at an early date your decision in the matter.
